Artificial Intelligence

Following the surge of excitement, as well as some trepidation towards AI recently, the topic is now high on the agenda of many organisations. The EU AI Act, and the UK's principles-based approach, are resulting in organisations reviewing the legal risks associated with use of AI systems.



Companies in the UK and beyond are at **different stages in their Al journey**, some having plunged headfirst and others taking a more cautious approach.



The use of AI can offer considerable benefits and opportunities, from simple business efficiencies to competitive commercial advantages. However, **uncertainties and risks** remain, including from a legal perspective. Clients are increasingly instructing us to advise around AI related risks.



One key area is contracting for Al. Where **contracting for an Al system, this gives rise to a host of new issues and complexities.** Agreements and related policies and procurement checklists should be reviewed with this in mind to **ensure they are fit for purpose and protect relevant business interests**, while also ensuring compliance with applicable regulatory obligations.



Regulation of AI and governance AI frameworks are also areas of focus for us and our clients.


